ORDINANCE OF THE TRIBAL COUNCIL OF THE OGLALA SIOUX TRIBE ADOPTING AN AMENDMENT TO OST ORDINANCE NO. 10-06 "ESTABLISHING AND ADOPTING THE PROCESS FOR SPECIAL TRIBAL COUNCIL MEETINGS UNDER ARTICLE IV OF THE TRIBAL CONSTITUTION" TO RESCIND PROVISION NUMBER 4.

WHEREAS, the Oglala Sioux Tribe adopted its Constitution and By-Laws by referendum vote on December 14, 1935, in accordance with Section 16 of the Indian Reorganization Act of 1934 (25 U.S.C. § 5123), and under Article III of the Constitution, the Oglala Sioux Tribal Council is the governing body of the Oglala Sioux Tribe, and

WHEREAS, pursuant to the Constitution and By-laws of the Oglala Sioux Tribe, the Oglala Sioux Tribal Council exercises legislative powers to enact and promulgate resolutions and ordinances, and

WHEREAS, Article IV, Section 1(s) of the Constitution authorizes the Tribal Council "to adopt laws regulating the procedure of the Tribal Council, the Executive Committee, Chartered Organizations, and sub-committees of the Tribal Council, and to adopt laws establishing the order of business during Regular and Special Meetings of the Tribal Council, and

WHEREAS, Section 4 of the Special Council Meeting Ordinance (10-06) only allows for agenda items included in the notice of special meeting, and

WHEREAS, by motion and vote, on December 17th, 2020, the Finance Committee recommended an amendment to Ordinance No. 10-06 to rescind Section 4 and allow add-on items to Special Council meeting agendas as written, and

WHEREAS, the Tribal Council agrees with the foregoing recommendation of the Finance Committee, now

THEREFORE BE IT ORDAINED, that the Tribal Council of the Oglala Sioux Tribe hereby adopts the following amendment to Ordinance No. 10-06: Rescinding Section 4 to remove the requirement that only items listed on the signed petition be allowed on the agenda, and

BE IT FURTHER ORDAINED that this Ordinance shall go into effect on January 04, 2021, and shall supersede, repeal, and replace all prior, inconsistent laws of the Oglala Sioux Tribe.




