RESOLUTION OF THE OGLALA SIOUX TRIBAL COUNCIL OF THE OGLALA SIOUX TRIBE REQUESTING AN IMMEDIATE DRAWDOWN AND WIRE TRANSFER OF FUNDS FROM RANGE ACCOUNT PL7112706 HELD FOR THE BENEFIT OF THE OGLALA SIOUX TRIBE BY THE OFFICE OF TRUST FUNDS MANAGEMENT IN THE OFFICE OF THE SPECIAL TRUSTEE FOR AMERICAN INDIANS IN THE U.S. DEPARTMENT OF THE INTERIOR FOR THE PURPOSE OF MAKING PAYMENTS ON THE OGLALA SIOUX TRIBE'S FARM SERVICE AGENCY (FSA) INDIAN TRIBAL LAND ACQUISITION PROGRAM (ITLAP) LOANS.

WHEREAS, the Oglala Sioux Tribe adopted its Constitution and By-laws by referendum vote on December 14, 1935, in accordance with the Indian Reorganization Act of 1934, and under Article III of the Oglala Sioux Tribe Constitution, the Oglala Sioux Tribal Council is the governing body of the Oglala Sioux Tribe, and

WHEREAS, under Article IV, Section 1(f), the Oglala Sioux Tribal Council has the authority to manage all economic affairs of the Oglala Sioux Tribe, and

WHEREAS, the Oglala Sioux Tribal Council enacts this Resolution to request a wire transfer of funds held in trust for the Oglala Sioux Tribe by the Office of Trust Funds Management (OTFM) in the Office of the Special Trustee for American Indians in the U.S. Department of the Interior in order to make payments on the Oglala Sioux Tribe's Farm Service Agency (FSA) Indian Tribal Land Acquisition Program (ITLAP) loans; now

THEREFORE BE IT RESOLVED, that the Oglala Sioux Tribal Council hereby requests a wire transfer of funds in the amount of \$413,062.00 from the Range Account PL7112706 held in trust by the Office of Trust Funds Management (OFTM) in the Office of the Special Trustee for American Indians in the U.S. Department of the Interior for the purpose of making payments on the Tribe's Farm Service Agency (FSA) Indian Tribal Land Acquisition Program (ITLAP) loans, and


BE IT FURTHER RESOLVED, that the Oglala Sioux Tribal Council requests that funds in the amount of \$413,062.00 be wire transferred immediately to the FSA consistent with instructions provided by the Treasurer of the Oglala Sioux Tribe, and

BE IT FURTHER RESOLVED, that the Oglala Sioux Tribal Council hereby renews its request for a complete write-off of the remaining balance of the principal and interest of its FSA loans for the reasons set forth in Resolution No. 20-201 (Nov. 24, 2020).
