RESOLUTION OF THE OGLALA SIOUX TRIBAL COUNCIL OF THE OGLALA SIOUX TRIBE APPROVING TO ADD JULIAN SPOTTED BEAR, ELLA JOHN CARLOW, SONIA LITTLE HAWK-WESTON, BERNARDO RODRIGUEZ, JR., GERALD COURNOYER JR., AND WENDELL YOUNGMAN JR., AS VOTING MEMBERS OF THE OGLALA SIOUX TRIBE FINANCE COMMITTEE.

WHEREAS, the Oglala Sioux Tribe adopted its Constitution and By-Laws by referendum vote on December 14, 1935, in accordance with Section 16 of the Indian Reorganization Act of 1934, (25 U.S.C. § 5123), and under Article III of the Oglala Sioux Tribe Constitution, the Oglala Sioux Tribal Council is the governing body of the Oglala Sioux Tribe, and

WHEREAS, Juliann Spotted Bear and Ella John Carlow have been elected as Pine Ridge District Representatives; Sonia Little Hawk-Weston has also been elected as Wakpamni District Representative; Bernardo Rodriguez, Jr., also has been elected as an Wounded Knee District Representative; Gerald Cournoyer Jr., has been elected as an Medicine Root District Representative, and Wendell Youngman Jr., has been elected an Oglala District Representative; they have all expressed their desire to be on the Oglala Sioux Tribe Finance Committee as voting members, and


WHEREAS, the OST Finance Committee did meet on the 31st day of December, 2020, with a quorum present, and did approve the additions of the aforementioned to the OST Finance Committee, as voting members; now

THEREFORE BE IT RESOLVED, that the Oglala Sioux Tribal Council does hereby approve, based upon the recommendation of the OST Finance Committee, the additions of Ms. Juliann Spotted Bear, Ms. Ella John Carlow, Mrs. Sonia Little Hawk-Weston, Mr. Bernardo Rodriguez Jr., Mr. Gerald Cournoyer Jr., and Mr. Wendell Youngman Jr., as voting members of the OST Finance Committee.
