RESOLUTION OF THE OGLALA SIOUX TRIBAL COUNCIL OF THE OGLALA SIOUX TRIBE APPROVING THE CONTRACT WITH DOUG O'BRYAN CONTRACTING, INC. FOR WANBLEE NORTH WATER STORAGE TANK REPAIR ON THE PINE RIDGE INDIAN RESERVATION.

Whereas, the Oglala Sioux Tribe is organized in accordance with Section 16 of the Indian Reorganization Act of 1934 on December 14, 1935, 25 U.S.C. 5123 by adopting a federally approved Constitution and By-laws, and under Article III of the Oglala Sioux Tribe's Constitution, the Tribal Council is the governing body of the Oglala Sioux Tribe, and

WHEREAS, the Tribal Constitution authorizes the Tribal Council, in Article IV, Section 1(a) to negotiate with the Federal government on behalf of the Tribe, in Section 1(f) to manage all economic affairs and enterprises of the Tribe, in Section 1(g) to appropriate for public purposes of the Tribe any available Tribal Council funds, and in Section 1(w) to protect and promote the health and general welfare of the Oglala Sioux Tribe and its membership, and

WHEREAS, under the terms of a Memorandum of Agreement (MOA) between the Tribe and the Indian Health Service, bids were sought for the Wanblee North Water Storage Tank Repair on the Pine Ridge Indian Reservation, and

WHEREAS, in the bid letting and evaluation conducted under the MOA and involving the Tribal Water & Sewer Program and the Indian Health Service, one bid was received where the only bid submitted was by Doug O'Bryan Contracting, Inc. , and

WHEREAS; on the 22nd day of January, 2021, the Economic and Business Develop Committee of the Tribal Council met and voted to forward the final approval of the contract with Doug O'Bryan Contracting, Inc. , on to the full Tribal Council, and

WHEREAS, the Tribal Council has considered the matter and determined that it is in the best interest of the Tribe and its members to approve the contract with Doug O'Bryan Contracting, Inc., for the Wanblee North Water Storage Tank Repair; now


THEREFORE, BE IT RESOLVED that the Tribal Council of the Oglala Sioux Tribe does hereby approve the contract with by Doug O'Bryan Contracting, Inc., for the Wanblee North Water Storage Tank Repair, in the amount of \$25,994.80, and


