RESOLUTION OF THE OGLALA SIOUX TRIBAL COUNCIL OF THE OGLALA SIOUX TRIBE TO AUTHORIZE AND DIRECT THE TRIBAL PRESIDENT TO ISSUE A PUBLIC SERVICE ANNOUNCEMENT CONCERNING THE TIPI RAISERS.

WHEREAS, the Oglala Sioux Tribe adopted its Constitution and By-Laws by referendum vote on December 14, 1935, in accordance with Section 16 of the Indian Reorganization Act of 1934 (25 U.S.C. § 5123) and under Article III of the Oglala Sioux Tribe Constitution, the Oglala Sioux Tribal Council is the governing body of the Oglala Sioux Tribe, and

WHEREAS, pursuant to Article IV, Sections 1(f), 1(k), 1(m), and 1(w), of the Tribal Constitution, the Tribal Council has the authority to manage the economic affairs of the Tribe, protect and preserve the property of the Tribe, adopt laws governing the conduct of persons on the Pine Ridge Indian Reservation, and adopt laws protecting and promoting the health and general welfare of the Oglala Sioux Tribe and its membership, and

WHEREAS, on February 22, 2021, the Finance Committee of the Tribal Council was advised that a nonprofit corporation called The Tipi Raisers is engaged in activities on the Pine Ridge Indian Reservation and that concerns have arisen concerning its practices and activities, and the matter has been referred to the Attorney General of the Oglala Sioux Tribe for further investigation, and


WHEREAS, on February 22, 2021, the Finance Committee of the Tribal Council passed a motion to authorize the Tribal President to issue a public service announcement to inform the general public that The Tipi Raisers is not affiliated with the Oglala Sioux Tribe and their activities on the Pine Ridge Indian Reservation are under investigation by the Attorney General of the Oglala Sioux Tribe; now

THEREFORE, BE IT RESOLVED, that the Oglala Sioux Tribal Council hereby authorizes and directs the Tribal President to issue the following public service announcement: "The Tipi Raisers is a non-profit corporation that is not affiliated with the Oglala Sioux Tribe and their activities on the Pine Ridge Indian Reservation are under investigation by the Attorney General of the Oglala Sioux Tribe."
