RESOLUTION OF THE OGLALA SIOUX TRIBAL COUNCIL APPROVING THE CONTRACT WITH MAIN SAVER - NORTH CENTRAL, INC. DBA PIPE DETECTIVES FOR INSPECTION OF THE WANBLEE CCTV OF SEWER PIPES ON THE PINE RIDGE INDIAN RESERVATION.

Whereas, the Oglala Sioux Tribe is organized in accordance with Section 16 of the Indian Reorganization Act of 1934 on December 14, 1935, 25 U.S.C. 5123 by adopting a federally approved Constitution and By-laws, and under Article III of the Oglala Sioux Tribe's Constitution, the Tribal Council is the governing body of the Oglala Sioux Tribe, and

WHEREAS, the Tribal Constitution authorizes the Tribal Council, in Article IV, Section 1(a) to negotiate with the Federal government on behalf of the Tribe, in Section 1(f) to manage all economic affairs and enterprises of the Tribe, in Section 1(g) to appropriate for public purposes of the Tribe any available Tribal Council funds, and in Section 1(w) to protect and promote the health and general welfare of the Oglala Sioux Tribe and its membership, and

WHEREAS, under the terms of a Memorandum of Agreement (MOA) between the Tribe and the Indian Health Service, bids were sought for the Inspection of the Wanblee CCTV of Sewer Pipes on the Pine Ridge Indian Reservation, and

WHEREAS, in the bid letting and evaluation conducted under the MOA and involving the Tribal Water & Sewer Program and the Indian Health Service, two bids were received with the low apparent bid submitted by Main Saver - North Central, Inc. DBA Pipe Detectives, and

WHEREAS; on the 22nd day of February, 2021, the Land & Natural Resources Committee of the Tribal Council met and voted to forward the final approval of the contract with Main Saver - North Central, Inc. DBA Pipe Detectives, on to the full Tribal Council, and

WHEREAS, the Tribal Council has considered the matter and determined that it is in the best interest of the Tribe and its members to approve the contract with Main Saver - North Central, Inc. DBA Pipe Detectives, for the Inspection of the Wanblee CCTV of Sewer Pipes; now


THEREFORE BE IT RESOLVED that the Tribal Council of the Oglala Sioux Tribe does hereby approve the contract with Main Saver - North Central, Inc. DBA Pipe Detectives, for the Inspection of the Wanblee CCTV of Sewer Pipes, in the amount of \$98,808.50, and

BE IT FURTHER RESOLVED that the Tribal Council understands that in the event Main Saver - North Central, Inc. DBA Pipe Detectives, does not obtain adequate bonding as required by the project within 10 days of receipt of notice of this approval, the project will be offered to the next lowest bidder, and


BE IT FURTHER RESOLVED, that the Oglala Sioux Tribal President or in his absence the Vice President is hereby authorized to sign any documents necessary to execute this contract.
